# CITY COUNCIL MEETING Minutes Special Meeting December 29, 2020

The following Council Members answering roll call:

Mayor Stinson opened the meeting explaining the purpose was to appoint a Fire Chief and Assistant Chief per Ordinance 33.05-2000. Both positions per resolution expires on December 31, 2020. He had requested in November any interested parties of either position submit a resume detailing their experience, certifications, training, and reasons for seeking the positions. He reported there were two submissions for Fire Chief; Dave Klaber and Darrin Brown. There were three submissions for Assistant Fire Chief; John Lucas, Travis Reis, and Kenny Gibson. Mayor stated before the ballots were issued, Mr. Brown asked to speak and announced that he was withdrawing his name from the ballot as Chief due to his resignation effective December 31, 2020. A vote was then taken for Assistant Chief and by majority of vote of firemen, John Lucas won.

Sebastian Ernst asked to speak and questioned why this appointment was being done in December and not in January when the new council is seated as term would begin January 1, 2021. After lengthy discussion regarding the wording of ordinance and no specific date as to action taken in December or January it was decided to table until full Council convened in January.

**MOTION**: Amy Hurst made a motion to appoint Dave Klaber as Interim Chief until a meeting of the new Council can convene to ensure fire coverage until such time a Chief is appointed; seconded by Shannon Johnson. Roll call vote: Hurst-yes; Johnson-yes; Carson-no; Price-no; not voting Dave Klaber. Due to a tie vote, Mayor Stinson voted to appoint Interim Chief.

**MOTION**: Amy Hurst made a motion to appoint John Lucas as Interim Assistant Fire Chief until a meeting of the new Council can convene to ensure fire coverage until such time an Assistant Fire Chief is appointed; second by Shannon Johnson. Roll Call Vote: Luke Price-no; Carson-no; Hurst-yes; Johnson-yes. Due to a tie vote, Mayor Stinson voted to appoint Interim Assistant Fire Chief.

#### ORDINANCES/RESOLUTIONS

Mayor then explained the need to pass a resolution accepting the re-appointment of several members to the Northern Kentucky Regional Ethics Authority along with new members. For the new Council in



attendance, he explained the NKADD had taken over the Ethics Board for Falmouth, and as such appoints members to the board. It was asked how those members are chosen and no one really knew but would ask the question to the governing body and report back.

**Resolution 12.29.20:3-**Approving reappointment of current members and appointment of new members to the NKREA for two-year terms.

**MOTION**: Dave Klaber made a motion to approve **Resolution 12.29.20:3** approving appointments to the NKREA; seconded by Amy Hurst. Vote carried 5-0-0

At this juncture, all Councilmembers were sworn in and given the Oath of Office.
