A RESOLUTION DECLARING BOTH 2001 FORD HAFT TON 2WD TRUCK & 1999 FORD ¾ TON 4WD TRUCK, INTENDED AND USED BY THE CITY OF FALMOUTH WATER/SEWER DEPARTMENT, AS SURPLUS TO THE NEEDS OF THE CITY AND THUS IN THE PUBLIC INTEREST TO DISPOSE OF SAME BECAUSE THE VEHICLE, WHILE OPERABLE, PRESENTLY TAKES UP NEEDED STORAGE SPACE, IS NOT ECONOMICAL FOR THE CITY TO PAY UPKEEP, AND IS SURPLUS TO THE NEEDS OF THE CITY, AND AUTHORIZING AND DIRECTING THE SALE OF SAID VEHICLE BY PUBLIC SEALED BIDS.

Be it resolved by the City of Falmouth:

Section 1. That a 2001 Ford Half Ton 2wd Truck, VIN #1FTRF17WX1NA20671, and 1999 ford 3/4 Ton 4WD Vin#1FTPF28LOXKB90257 truck, while operable, is hereby declared surplus to the needs of the City.

Section 2. That at the time of acquisition, the 2001 Ford and 1999 Ford Trucks were intended and used by the City of Falmouth Water/Sewer Department.

Section 3. That it is in the public interest to declare this vehicle as surplus and to dispose of same because it is taking up needed storage space, is not economical for the City for pay for upkeep, and is simply excess to the needs of the City.

Section 4. That the City Clerk be directed to advertise this sale by public sealed bids in accordance with KRS 424.130 (1) (b), prior to said sale.

Section 5. This resolution shall take effect upon its passage and approval as required by law.
