A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR, ON BEHALF OF THE CITY OF FALMOUTH, TO EXECUTE A CONTRACT AGREEMENT AND DEED WITH SAUL AND ANGELA BEX, FOR THE PURPOSE OF REAL ESTATE PURCHASE OF THE CITY OF FALMOUTH SURPLUS PROPERTY LOCATED AT THE END OF HAMMER DRIVE CONSISTING OF 37.2996 ACRE MOREOR-LESS LOCATED IN PENDLETON COUNTY FOR THE AMOUNT OF \$62,502.00 PLUS CLOSING COST PAID BY BUYER.
